REGULATIONS OF THE BALOISE NAMUR MARATHON

Saturday 11 and Sunday 12 April 2026

ARTICLE 1 - PREAMBLE

The seventh edition of the Baloise Namur Marathon (hereinafter the "Event") is organized on Saturday 11 and Sunday 12 April 2026 by We4sport, a non-profit organisation, registered with the Belgian Legal Entities Register under number 0699.612.894, whose registered office is located at 54, Avenue des Acacias, 5101 – Namur, Belgium (hereinafter the "Organizer").

These Regulations apply to every participant in the Event.

The Organizer may revise and update these Regulations up to the day before the Event. All changes made shall apply immediately after they have been notified by email or published on the website of the Event.

ARTICLE 2 - ADRESSES AND DATES

2.1. Adresses

- Finish line of the Marathon, the Half Marathon and the 10K KickCancer: Avenue Fonds des Bas Prés, 5000 Namur.
- Bib collection, expo village, physio, post-race refreshments, entertainment and bars: Namur Expo, Avenue Sergent Vrithoff 2, 5000 Namur.

2.2. Dates

- Saturday 11 April 2026:
 - Materne Kids Run: 3:30 p.m.
- Sunday 12 April 2026:
 - Start of the Namur Marathon: 9:00 a.m.
 - Start of the Namur Half Marathon: 9:30 a.m.
 - Start of the Namur 10K Kick Cancer: 1:00 p.m.

ARTICLE 3 – THE COURSE

The Marathon course is 42.195 km.

The Half Marathon course is 21.097 km.

The 10K Kick Cancer course is approximately 10.2 km.

Course details are presented on the Event website and its social networks.

ARTICLE 4 - CONDITIONS OF PARTICIPATION

To take part in the Marathon and the Half Marathon, the participant must be at least sixteen (16) years old as of the day of the Event.

To take part in the 10K Kick Cancer, the participant must be at least fourteen (14) years old as of the day of the Event.

The Events are open:

- to licensed and non-licensed runners;
- to people with reduced mobility (PRM) (except hand bikes, which are prohibited for safety reasons)

Strollers are allowed on the only condition that they start behind all other runners for safety reasons.

Cani cross is strictly prohibited.

Please note that checks will be carried out during the Event to ensure perfect conditions of fairness in the race.

It is explicitly stated that runners take part in the competition under their own and only responsibility.

Upon registration, the participant must select the statement "I certify that I am in good health." The Organizer recommends a preventive sports medicine examination by an approved sports physician before taking part in such an event.

ARTICLE 5 - REGISTRATION PROCEDURES AND INDIVIDUAL FEES

5.1. Registration procedures

Registrations for the Event are made exclusively on the online registration platform accessible at the following address: https://www.baloisenamurmarathon.com from 24 August 2025 at 7:00 p.m.

The number of places is limited to 11,000 runners. No waiting list will be set up.

The Organizer reserves the right to refuse a registration or to refuse access to the Event site without the possibility of a refund.

5.2. Fees for individual registration

For each runner participating in the Marathon or the Half Marathon, a $\in 2$ deposit is added to the registration price. This deposit corresponds to a reusable cup for the post-race drink(s) in the runner's area. This amount will be refunded upon return of the cup.

ARTICLE 6 – GROUP / COMPANY REGISTRATION

6.1. Registration procedures

Registrations for the Event are made exclusively on the online registration platform accessible at the following address: https://www.baloisenamurmarathon.com from 24 August 2025 at 7:00 p.m.

There is no on-site registration for groups and companies.

Groups and companies must strictly comply with the following rules:

- Minimum 8 people;
- The group/company registration MUST be completed no later than Tuesday 3 March 2026 at 12:00 p.m. to obtain a personalized bib in the name of the group and according to the arrangements decided with the Organizer;
- From 3 March 2026 at 12:01 p.m. group registrations will be open until 29 March 2026 inclusive, but the bib will NOT be personalized and collection will take place on site;
- Payment for group/company registrations is a single payment for the entire group upon the Organizer's request;
- Only the group captain collects the bibs for all members of the group/company (see bib collection below);
- All runners must have completed their registration to allow the captain to collect the bibs.

6.2. Fees for collective registration

For each group, case management fees in a fixed amount of \in 5 excluding VAT are applied, as well as an amount of \in 0.75 excluding VAT per participant.

ARTICLE 8 - COMMITMENT

Participants must be in good health and physically fit for competitive running.

Since all registrations are firm and final, no refund will be made in the event of a registration error, a medical impediment, or unavailability, except in the cases specified in Article 16.1 of these Regulations which set out the terms.

Except in the cases provided for in Article 9 of these Regulations, no transfer of bib is authorized for any reason whatsoever.

Any person who transfers their bib to a third party will be held responsible in the event of an accident occurring or caused by the latter during the Event.

The Organizer declines all liability in the event of an accident in such a situation.

The bib must be visible and its information fully legible during the race.

Participants registered in 2025 receive a 10% discount valid until 1 December 2025 inclusive. This discount is personal and non-transferable. If a runner were to transfer their discount, the registration will be null and void.

ARTICLE 9 - BIB TRANSFER

The transfer of a bib is authorized upon payment from 1 January 2026 via the registration platform.

From 9 April 2026, all transfer requests must be made ONLY on Saturday 11 April 2026 on site at Namur Expo.

The price of a bib transfer is €5.

ARTICLE 10 - INDIVIDUAL BIB COLLECTION

Bibs will be collected upon presentation of your registration confirmation, sent by email before the Event and/or your valid official identity document.

Your bib can be collected at the Trakks store of your choice from Wednesday 18 March 2026 for any registration validated no later than Tuesday 3 March 2026 at 12:00 p.m. Bibs can be collected at the Trakks stores in Gosselies, Etterbeek, Rocourt and Uccle until Thursday 9 April 2026 and at the Trakks store in Jambes until Friday 10 April 2026.

The choice of store is final at the time of registration and cannot be changed.

After 3 March 2026 at 12:00 p.m., the bib must be collected on site at Namur Expo on 11 and 12 April 2026. It will be personalized for any participant registered no later than 29 March 2026 at 11:59 p.m.

Any bib allocation is firm and final.

The bib will be required to access the start area and must remain fully legible during the race, including in bad weather.

ARTICLE 10.BIS - GROUP / COMPANY BIB COLLECTION

Bibs will be collected upon presentation of the registration confirmation, sent by email before the Event.

All the group/company bibs can be collected at the Trakks store of your choice from Wednesday 18 March 2026 for any registration validated on Tuesday 3 March 2026 at 12:00 p.m. <u>The choice of store is final at the time of registration and cannot be changed.</u>

Once a group is closed, it is no longer possible to add runners.

After 3 March 2026 at 12:00 p.m. group bibs must be collected on site at Namur-Expo on 11 and 12 April 2026. They will be personalized for any participant registered no later than 29 March 2026 at 11:59 p.m.

Any bib allocation is firm and final.

The bib will be required to access the start area and must remain fully legible during the race, including in bad weather.

ARTICLE 11 - OFFICIAL JURY

11.1. Timing

Timing will be displayed at the finish.

All participants are given an electronic chip when collecting their bib (chip stuck on the back of each bib) which will be automatically activated when passing the start line and will serve as a regularity control during the race. A participant not using the roadway cannot be classified at the finish.

The electronic detection system is selected according to strict reliability criteria. Despite the tests carried out by the manufacturers, there always remains a very low percentage of non-detection. The absence of data resulting from such non-detection will not allow the Organizer to include the official or net time of the participant concerned in the rankings. The Organizer cannot be held responsible.

11.2. Refreshments

Refreshment stations are installed approximately every 5 km as well as at the finish. The distance may vary and will be specified on the course for runners' safety reasons.

11.3. Maximum time

Participants in the Marathon will have a maximum time of 6 hours to complete the course to the finish line. Participants in the Half Marathon and in the 10K Kick Cancer must cross the finish line by 3:00 p.m. at the latest.

After the passage of the sweep vehicle, and by unilateral decision of the organization, a participant may be declared over time, meaning their immediate withdrawal from the race; they must then comply with the traffic rules.

Any runner withdrawn from the race who decides to continue does so under their entire responsibility; the Organizer cannot be held responsible in the event of an accident.

ARTICLE 12 - GENERAL SERVICES

Police and emergency information. See website as the race approaches.

ARTICLE 13 - ACCESS TO THE SITE AND SECURITY

Bringing any object onto the Event site that could be dangerous or illegal, including drugs, firearms, blunt objects and explosive materials, is strictly prohibited.

To access the site and to participate in the Event, the participant expressly acknowledges and accepts that the Organizer may call on security personnel who will be authorized to check both individuals and their personal belongings. Any person wishing to access the site agrees to submit to this check. In the event of refusal, the person will not be allowed to access the site.

The Organizer as well as the security personnel are authorized to refuse access to the Event or the continuation of the race to participants whose behaviour is likely to disrupt the proper running of the Event, including but not limited to: bringing any object that could potentially hinder in any way the progress of the race, the circulation and/or the safety of other participants; bringing any distinctive sign promoting, in any form whatsoever, a political, philosophical or religious opinion likely to harm the image of the Event; abnormal, inappropriate or immoral behaviour by the participant, notably if they appear to be under the influence of drugs or alcohol. The course takes place on roads or half-roads closed to traffic. Nevertheless, participants must comply with the traffic rules of the Highway Code.

ARTICLE 14 - TRANSPORT

The starts of the Namur Marathon and the Namur Half Marathon are given in places different from the finish. The price of the shuttle is included in the Marathon registration.

Paid shuttles are organized for the Half Marathon and the 10K: train and bus for the half marathon runners and bus for the 10K KickCancer.

The price of the shuttle is €3.99. The choice of shuttle is made at registration. Your choice is firm and final and cannot be modified thereafter.

ARTICLE 15 - INSURANCE

15.1. Civil liability

In accordance with the legislation in force, the Organizer has taken out insurance covering the financial consequences of its civil liability, that of its employees and of all participants in the Event. Regarding the civil liability of participants, this insurance intervention for the latter is limited to accidents they may cause during the Event.

This guarantee will apply in addition to or in the absence of other insurances from which participants may benefit elsewhere. Proof can be provided to any participant upon simple request.

15.2. Material damage

The Organizer declines all responsibility in the event of damage (theft, breakage, loss, etc.) suffered by participants' personal belongings, even if they are in its custody. Participants will therefore not be able to turn against the Organizer for any damage caused to their equipment. Taking out insurance covering these risks is the responsibility of each individual.

ARTICLE 16 - CANCELLATION BY THE CLIENT

- 16.1. The Client has the possibility of taking out cancellation insurance in return for an increase in the price. The amount is €12 for the Marathon, €9 for the Half Marathon and €6 for the 10K. By way of derogation from Article 8 of these Rules, the Client who has subscribed to this product has the possibility of being reimbursed for their registration without mentioning particular reasons. Any options such as a T-shirt, medal engraving, the shuttle and the cancellation policy itself will not be reimbursed (non-limiting).
- 16.2. If circumstances so require (administrative decision, weather or health circumstances, insufficient registration), the Organizer reserves the right to modify at any time the course, the distance to be covered, and to postpone the date and/or the times of the Event, without incurring any liability.
- 16.3. In the event of a change to the dates of an Event, the Client has the right to cancel their registration and obtain a refund provided that this request is brought to the Organizer's attention in writing within 14 working days following the date on which the change of date was notified to the Client.

In the absence of a response from the Client within this period, their registration will be deemed confirmed for the new dates.

16.4. Without prejudice to special regimes to be adopted by the competent authorities, the threat of the Covid-19 virus and the taking of measures against it as well as the threat of other epidemics and the taking of measures against them, as well as any act of state, strikes, lock-outs, riots, mobilization, bad weather, shortages of equipment or means of transport, fires, terrorism, risks of terrorism, etc., are by default considered, for the purposes hereof, as

constituting a case of force majeure justifying the cancellation of an Event without the Organizer having to demonstrate the unpredictability or irresistibility of the circumstances and the impossibility of performing its obligations. The same applies to the cancellation of the Event due to usual symptoms of the Covid-19 virus detected in a Client or any events external to the Organizer; it cannot be held responsible. If such events occur, the Organizer is not obliged to refund all or part of the registration price.

16.5. Termination

The Organizer and the Client reserve the possibility of terminating the contractual relationship at any time in the event of non-compliance by the other party with any of its obligations under these Regulations, without prejudice to any damages that may be claimed from the defaulting party.

16.6. The termination of the contractual relationship in the event of a fault by the Client entails the immediate enforceability of the sums remaining due.

ARTICLE 17 - USE OF IMAGES

17.1. Image of the participant

The Event may be recorded for the purpose of communication to the public, in any form (notably photos, videos, etc.), on any existing or future medium, in any format, for any communication to the public worldwide, for any use including for advertising and/or commercial purposes. Each participant expressly authorizes the Organizer, its assigns or successors (notably its commercial partners) to capture and reproduce, on any medium and by any means, and consequently to reproduce and represent, without any remuneration whatsoever, their name, voice, image, and more generally their sporting performance within the framework of the Event (hereinafter "their Image"), for an indefinite period following the date of the Event. The participant expressly authorizes the Organizer to grant the Event's partners sublicenses to exploit their Image for commercial and advertising use of the Image.

For this purpose, each participant expressly and irrevocably authorizes the Organizer, its assigns, its successors (notably its commercial partners), in order to meet the requirements of advertising, promotional and/or commercial campaigns to 1) make any modification, addition, deletion it deems useful for the exploitation of their Image under the conditions defined above, 2) associate and/or combine with their Image any signatures, hooks, slogans, captions, trademarks, distinctive signs, legal notices, visuals and, generally

speaking, any element of any nature at the Organizer's choice intended in particular to illustrate the communication media in which they are integrated.

The participant guarantees that they are not bound by any exclusive contract relating to the use of their Image.

The Organizer, its assigns, its successors expressly refrain from using the name, voice or image of participants in any medium of a pornographic, racist, xenophobic nature and, more generally, refrain from any use detrimental to the dignity of participants.

The participant is informed and unreservedly accepts that their Image captured by the Organizer's official providers may be accessible on the Organizer's website and on the Event website. Regarding the Event website, the participant accepts that they may be identified by any internet user by their surname, given name and/or bib number.

17.2. Images of the Event

Any communication of still images and/or videos of the Event captured by the participant during their participation in the Event must be limited to personal use and may under no circumstances be exploited for promotional and/or commercial purposes external to the Event.

17.3. Aerial images

Participants are informed that:

- On the day of the Event, remotely piloted aircraft (drones) may be used for filming purposes;
- They may be situated, during all or part of their participation in the Event, less than 30 meters from said aircraft;
- Where appropriate, safety instructions will be communicated and must be strictly complied with.

ARTICLE 18 - PERSONAL DATA

In general, the personal data communicated by participants (hereinafter the "Data") are intended for authorized staff of We4sport non-profit organisation, which is the organization responsible for processing these data.

The Data are used for processing and monitoring their orders relating to the Event, after-sales service of the products ordered, marketing and customer relationship management, debt collection, the fight against fraud, as well as

business prospecting and the sending of promotional offers from We4sport non-profit organisation.

The Data may be transmitted to the Organizer's service providers for the purpose of processing the orders and related services offered (notably your photos by the Official Photographer, medal personalization, etc.) and aftersales service as well as for customer relationship management purposes. Participants may receive, by telephone and/or postal mail or by email or SMS, promotional offers from the Organizer's commercial partners to whom the Data may be transmitted and assigned for prospecting purposes, provided that the participant has ticked the box provided for this purpose when registering on the Event website when creating their account or later when registering for the Event. In any event, the participant can always object in their "Member" area or under the conditions set out below.

The participant may exercise their rights of inquiry, access, rectification and deletion regarding all data concerning them by sending their request by email to info@baloisenamurmarathon.com.

ARTICLE 19 - PROTECTION OF PRIVACY

The processing of personal data is subject to Belgian law (Law of 8 December 1992 on the protection of privacy with regard to the processing of personal data, as amended by the law of 11 December 1998 transposing Directive 95/46/EC of 24 October 1995 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data).

ARTICLE 20 - RESPECT FOR THE ENVIRONMENT

To respect the environment and the natural areas crossed, it is strictly forbidden to leave waste on the course. Bins are available at each refreshment station and "collection zones" are installed and signposted at different points along the course. They must be used by participants.

Participants must keep their waste and packaging until the places indicated by the Organizer to dispose of them.

Any participant who does not comply with Article 20 will be taken out of the race.

ARTICLE 21 - EQUIPMENT PROHIBITED ON THE COURSE

Bicycles, wheeled and/or motorized vehicles are strictly prohibited on the course. Any participant followed by the above-mentioned means of transport will be taken out of the race, except for the Organizer's and race marshals' mechanical and electric bicycles.

ARTICLE 22 - ANTI-DOPING

Anti-doping controls may be implemented during the Event. Participants in the Event undertake to strictly comply with the ban on doping as well as with the provisions concerning anti-doping controls, as they result from the laws and regulations in force.

ARTICLE 23 - APPLICABLE LAW - DISPUTES

Belgian law applies in the event of a dispute.
